Daniel Karrenberg: (15:35) @chris: there is a global policy development process for Internet Number policy. This transition is about (the IANA part of) the \*implementation of these policies.

Alan Barrett (NRO): (15:36) RIRs SLA will be with ICANN, not with PTI. SLA will allow ICANN to subcontract to PTI.

arasteh: (15:36) Pls also clearly mention that IRP does not intend to intervene on CCTLD as they need to find a satisfactory way on how to handle the matter

Daniel Karrenberg: (15:36) So there is no plan to change the Internet number policy development process as part of this transition.

arasteh: (15:36)

Chip Sharp (Cisco): (15:36) @Daniel: re PDP, that's what I thought. Thx for confirming.

arasteh: (15:37) aLLISA

arasteh: (15:37) Alissa

arasteh: (15:38) The MoU BETWEEN IETF and ICANN should be an open process subject to community comments and empowerment

arasteh: (15:38) Deare All

arasteh: (15:39) There is no proclamation of any type of independence

arasteh: (15:39) There is a strong link between Numbers, Parameters and Protocol , on the one hand and DNS on the other hand

Chip Sharp (Cisco): (15:39) @Alan - Got it. Thx.

Lynn St.Amour: (15:40) @Kavouss, we should let Alissa complete the presentation. The MOU between the IETF and ICANN is an open process. This can be discussed offline but is most appropriately done within the Numbers OC

arasteh: (15:41) Pls not that the any action taken by ICANN in regard with MoU between IETF and CRISP ( rIRE) is subject to community empowerment

arasteh: (15:41) There is no exclusion at all

arasteh: (15:41) LYNN N

An example: the IANA PLAN WG directed the IETF leadership to add 2 things to the yearly SLA as a part of the transition. The details are up to the lawyers, in this case but the community does direct our work.

Avri Doria: (15:54) Question: will the ICG have a role in resolving pending issue like the disposition of the IANA domain name and various marks.

Daniel Karrenberg: (15:54) i could hear alan both on the conference bridge and on adobe

Keith Drazek (gTLD Registries): (15:54) Responding to the question from Bob: There are no current fees or payments associated with the performance of the IANA Functions.

Alan Greenberg: (15:54) ICANN pays for everything just as now.

Keith Drazek (gTLD Registries): (15:54) And there are no new fees or payments anticipated.

Keith Drazek (gTLD Registries): (15:55) Thanks Alissa.

Bob: (15:55) Thanks

Patrik Fältström: (15:56) I got a question privately regarding recording of this webinar.

Keith Drazek (gTLD Registries): (15:56) To support Alan Greenberg's comment above, ICANN currently performs the IANA functions, but collects no fees for them. ICANN does collect fees from ICANN-accredited registries and registrars, which in turn helps fund the performance of the IANA functions.

Avri Doria: (15:57) So the Numbers proposal is the reference solution? thanks.

Jean-Jacques Subrenat: (15:58) @Avri: it was the only one proposed, and not opposed, so ICG is forwarding that.

arasteh: (15:58) Alissa

Alan Greenberg: (15:58) ICANN collects funds from some ccTLDs as well.

arasteh: (15:59) I raised some question in form of comment for your consideration in tomorrow's Webinar

arasteh: (15:59) Tks

Keith Drazek (gTLD Registries): (15:59) +1 Alan, both ICANN-accredited gTLD registries/registrar and some ccTLD registries. Approximately 94% comes from gTLDs.

Avri Doria: (15:59) So if we object to moving the domain name and mark to the IETF Trust, we need to comment on that.

arasteh: (15:59) Alissa

Daniel Karrenberg: (16:00) On the IPR I recall that the IETF made a statement referencing the IPR related proposal by the RIRs

arasteh: (16:00) under any other business,\$0

Daniel Karrenberg: (16:00) Is that worth explaining?

arasteh: (16:00) I have an important point to raise

Jari Arkko: (16:00) Daniel: I can confirm that the ICG asked of IETF if we can live with the CRISP proposal. We said yes.

RussMundy-SSAC: (16:01) @Avri: Yes, that would be a useful input to the ICG public comment process

Daniel Karrenberg: (16:01) i am talking

Daniel Karrenberg: (16:01) on the bridge

Alan Greenberg: (16:01) We can't hear you!

Manal Ismail (GAC-ICG): (16:01) @Avri further coordination need to be done .. can be done post submission as far as nothing proposed is currently in contradiction ..

Jean-Jacques Subrenat: (16:01) @Alissa, Daniel's mic. is on, but his hand is not up.

Daniel Karrenberg: (16:01) move on while we resolve this

Alan Greenberg: (16:01) Unmute \*7

Daniel Karrenberg: (16:02) i am unmuted on the adobe and the bridge

Jari Arkko: (16:02) Avri: the important bit is that as long as we satisfy the requirements from CRISP in the implementation phase, we are all fine. Their specific suggestion does not have to be satisfied, it could be other forms. But their requirement of not holding the IPR at the operator needs to be satisfied.

Bob: (16:08) My reading of the IETF Trust definition allows it to hold IPR the benefit of the Internet.

Jari Arkko: (16:09) The details of actual agreements and arrangements regarding IPR and domains are TBD. However, in my view there has to be agreements where specific responsibilities and rights are assigned to parties (the operational communities and the IANA operator). In short yes.

Jari Arkko: (16:09) (speaking as one trustee, not representing trust officially)
